What is Generation Scotland?

We are Scotland's largest **family health study**. We track the health and wellbeing of all types of families over time.

However, you do not have to be part of a family to join our study. You can join as an individual.

So far 36,000+ volunteers have already helped research into cancer, dementia, diabetes, mental health and other health conditions using DNA.

Who can take part?

Anyone aged 12 and over who lives in Scotland can take part. You can sign up online anytime. You do not need to visit a health centre.

For 12- to 15-year-olds a parent or guardian needs to agree that you can join Generation Scotland. As it is a long-term study, they need to double check that you understand what you are signing up for.

What will I be asked to do?

- · Finish reading this information
- · Ask us if you have any questions

Complete the consent form (15 checkboxes)

- Provide contact details for your parent/guardian (name, email/mobile number & postcode) and let them know you want to join.
- Fill out the questionnaire about your health & wellbeing (15 mins max)
- After you complete the questionnaire, and your parent/guardian also agrees, a saliva sample kit will be sent to your home. Your 'spit kit'!

• Complete the saliva sample and return it for free by dropping it in any postbox. That is it, you've joined!

Once you have agreed to join Generation Scotland, we will ask for your parent or guardian's email address or mobile number and postcode, so we can ask them if they agree for you to join.

We send them a link to read the information we provided you. Then we ask them if they agree for you to join. If they do not agree you will not be able to join Generation Scotland and all the information we hold about you will be deleted. If this is the case you may choose to join at a later date. All 16-year-olds and over may join without a parent/guardian involvement.

Once you finish the online consent, you can start the **questionnaire**, which asks about your health and wellbeing. You can do it right away or return to it later if you like. It takes about 15 minutes to do.

All of our volunteers can use our online portal to update personal details and access future questionnaires. [END DROP DOWN]

Will I be paid?

You will be compensated for your time with a £20 e-voucher card. It is your choice if you would like to accept the e-voucher. You will receive it after you have finished the questionnaire and returned the saliva sample.

Benefits of taking part:

- Researchers can learn more about youth mental health and other health conditions, which could lead to new treatments and cures.
- We will keep you **updated** about our findings through our website, social media and e-newsletters.
- By joining you become part of a community helping to shape future research.

 Providing a saliva sample is a simple procedure, and you will receive step-by-step instructions, but some people might find it difficult.

We may ask about sensitive topics like alcohol use, smoking, feelings about food, body image, gender identity and bullying. You can skip any questions you do not want to answer.

What information do we collect?

We track the health of our volunteers by accessing **official records**, which may include:

- **NHS health records** such as: medications, vaccinations, hospital admissions, dentists, previous illnesses, appointments.
- Administrative records such as: records from Education Scotland, the Tax Office and the Department of Work and Pensions.

The types of official records available **can change over time**. In future, we may access more administrative records than we have suggested in this information sheet.

As we establish links to new official records **we will update you** on the type and what information it holds, although we won't be able to provide you with specifics. If you feel uncomfortable about any new linked record, please **reach out to us**.

Additionally, when/if doctors or nurses take samples to test, for example blood or urine samples, there is often some surplus left over. We may ask the NHS to keep the leftover sample for our research.

How do we link your data?

We access official records through a process called 'data linkage'. Data linkage is a safe and secure way to access official records and is used by many researchers across the UK.

How will my information, sample and data be stored and kept safe?

The Generation Scotland team will store your samples and data securely at a safe location at the University of Edinburgh, using a unique ID number instead of your personal details.

We follow General Data Protection Regulations (GDPR) to keep your information safe

We will **not share** your answers or data with:

- Your parent/guardian
- Your school
- · Your current or future places of work
- Insurance companies
- · Anyone other than approved researchers.

Who will be able to use my information and samples?

- The Generation Scotland team
- Approved researchers

All research must be ethically approved to benefit the public. Researchers may be from the NHS, universities, commercial companies or charities and they can be based in other countries.

We will let your GP know you are taking part in Generation Scotland, because we will request access to your health records.

Will I get information about my results?

No. This study is for research only and is **not for clinical treatment or genetic testing**. However, we provide useful resources and contacts for supporting young people and families on some of the topics covered in the study **here [link]**.

You can choose to take part or not.

You may be asked to join other studies based on:

- Information you have given (e.g. questionnaires)
- Information in your official records
- Genetic information from your saliva sample. We get this
 information from the DNA in your sample. DNA is found in people

 certain conditions.
- We often need a mix of people, including healthy people to match someone with a condition researchers are interested in.

Has Generation Scotland been checked as safe and secure?

Before health research can start it must be looked at carefully by a Research Ethics Committee. Their job is to protect your safety, rights and well-being. The **NHS East of Scotland Research Ethics Committee** reviewed and approved our project.

What if I want to stop taking part?

You can stop taking part at any time by contacting us by phone or email. You do not have to give a reason if you do not want to.

There are two types of withdrawal you can request:

- 1) No further contact: We will not contact you with updates or future study requests, but we can still use the information, samples and official records you gave.
- 2) No further use: In addition to "no further contact," we will not use your information and samples for new research, but this does not include ongoing or finished research.
